### **OPENING REPORTS**

Chairman Bob Dempster called the meeting to order.

Public Comment. Members of the public were present to discuss the I-229 Project.

### **NEW BUSINESS**

#### ALOP

The ALOP is the Annual Listing of Obligated Projects. Chance stated this is simply showing an outline on where they are for Federal Projects for the Transit Improvement Plan. In FY21, 36 projects in the St. Joseph region obligated a total of \$31,221,450.20 in federal transportation funds. There will be an updated TIP in the spring. No action is needed at this time, this is just a 90-day update to the TIP.

### Transit Development Plan-AECOM

Andrew Ittigson gave an update on the Transit Service Development Plan. A transit system assessment that identifies key mobility issues and community needs. The project provides recommendations for bus system improvements in areas including routing, reliability, ridership, productivity and efficiency. Mr. Ittigson went over the project tasks, schedule, service plan, new service considerations, and the next step. Scenario planning and runcut is next up on the schedule for September – October, before the final report is submitted.

Chance mentioned that along with the Transit Development Plan, Transit is also working on a re-branding plan, building a new transfer station in the future and just launched their RouteShout App to show real time bus locations.

### Project Update- MoDOT

Shannon Kusilek presented the Committee with project updates. Back in 2009-2010, a couple earmarks were given to MoDOT for work to be done at Alabama and US59 intersection and the other one was 169 and I-29 intersection by Loves Truckstop, but work was never completed and funds must be used by 2024. As part of the unfunded needs list, the intersection at Alabama and US59 has been identified as high priority needs, due to safety and congestion concerns. This project has kicked off and will identify the scope over the next few years, with construction beginning by January 2024.
